

TERMS AND CONDITIONS

Promotion Period:

1 June 2026 – 31 July 2026

1. DEFINITIONS

In these Terms and Conditions, the following words and expressions shall have the meanings set out below:

"Promoter" means Hobeca Trading Co Limited (NZBN: 9429040442464), the company responsible for conducting this Promotion.

"Retail Partner" means TradeZone, the exclusive retail partner through whom this Promotion is conducted.

"Promotion" means the TradeZone V210 Redemption Promotion conducted during the Promotion Period.

"Promotion Period" means the period commencing 12:00:01 am on 1 June 2026 and concluding at 11:59:59 pm on 31 July 2026 (New Zealand Standard Time).

"Eligible Product(s)" means any product listed in Schedule A of these Terms and Conditions, purchased from TradeZone during the Promotion Period.

"Eligible Entrant" means any individual who satisfies all Entry Eligibility Criteria set out in Clause 3.

"Entry" means a valid submission made in accordance with these Terms and Conditions.

"Proof of Purchase" means an original TradeZone tax invoice clearly showing the purchase of at least one Eligible Product, the purchase date, the product name, the product code, and the total purchase price.

"Prize(s)" means the prizes described in Schedule B of these Terms and Conditions.

"Draw Date" means the date on which prize winners are selected following the close of the Promotion Period.

"GST" means Goods and Services Tax as applicable under New Zealand law.

2. THE PROMOTER

2.1 This Promotion is conducted by the Promoter, Hobeca Trading Co Limited. TradeZone acts as the exclusive Retail Partner through whom this Promotion is made available to customers. TradeZone is not the Promoter and bears no responsibility for the administration, fulfilment, or prizes of this Promotion. 2.2 This Promotion is in no way sponsored, endorsed, or administered by any third-party social media platform, manufacturer, or brand whose products appear in the Promotion. TradeZone's role is limited to that of exclusive Retail Partner for sales of Eligible Products during the Promotion Period.

2.3 By participating in this Promotion, each Eligible Entrant releases and discharges any applicable third-party platform operators from any and all liability arising out of or in connection with this Promotion.

3. ENTRY ELIGIBILITY

3.1 To be eligible to enter this Promotion, an entrant must:

Be a resident of New Zealand;
